Dear Bank, Insurance Company and Financial Corporation Property Statement Filers,

**This is your notice to file a 2024 BOE business property statement.** Electronic filing (e-file) is now the preferred method for filing property statements. Below are *two* options on how to properly file form 571-L and 571-LA with our office.

## **Option #1 – Online Filing (SDR/e-SDR)**

Included in this envelope is a separate Notice to File letter that contains an account number and Business Identification Number (BIN#) you will use to e-file your property statement. Refer to this letter for filing instructions. Filers who use Form 571-L Business Property Statements and Alternate Schedule A (BOE 571-LA) can access their Cal Assessor SDR/e-SDR web portal at <a href="https://public.calbpsfile.org/home">https://public.calbpsfile.org/home</a> or on the Assessor's website at <a href="assessor.imperialcounty.org">assessor.imperialcounty.org</a>. On the Assessor's webpage, click on the SDR/e-SDR e-file icon to get started.

## Option #2 - Paper Form Filing

If you prefer to file all paper forms, fillable forms can be found and completed at <a href="http://assessor.imperialcounty.org/forms/">http://assessor.imperialcounty.org/forms/</a>. Completed 571 forms can be printed, delivered, mailed, or emailed to our office. Forms are also available upon request by calling (442) 265-1300 or e-mailing a request to <a href="https://assessor.imperialcounty.org/forms/">Assessor@co.imperial.ca.us</a>.

## The filing dates for both e-filers and paper form filers are as follows:

April 1, 2024: Property statements are due.

May 7, 2024: Final date to file property statements without a 10% late penalty.

May 31, 2024: Last date to amend timely filed property statements, without a penalty.

Statements and amendments are timely filed, if e-filed or postmarked by their respective due date.

If you utilize an independent accounting service to prepare your property statement, please forward this information to them. If you have permanently closed your business, please complete the Statement of Change Form that is printed on the back of the Notice to File letter included in this envelope.
